Revision of Fees and Charges for Services Related to Control of Animals and Plants and Registration of Veterinary Surgeons

Introduction

This paper invites Members to advise on the proposed adjustments of fees and charges for certain Government services related to the control of animals and plants and the registration of veterinary surgeons.

Background

2. At the LegCo Panel on Financial Affairs on 13 April 2000, Members were consulted on proposals to revise various fees and charges for services not directly affecting people's livelihood or general business activities. In this connection, Members suggested that the proposals should be considered by the relevant subject Panels of LegCo. At the House Committee meeting held on 14 April 2000, Members agreed that the respective LegCo Panels should be consulted on whether, and if so how, fees and charges under their purviews should be increased.

Administration's Proposals

- 3. The Administration's general policy is to recover 100% of the cost of providing the service. However, for a variety of reasons, some existing fees fall far short of full cost recovery. It is acknowledged that it would cause some difficulties if fees were increased rapidly to achieve 100% cost recovery. We therefore propose a phased increase, taking account of different circumstances, along the following lines
 - (a) achieve full-cost recovery within three to seven years for those fees with existing cost recovery rate of between 40% and 70%, through a 15% increase; and
 - (b) achieve full-cost recovery within one to three years for those

fees with existing cost recovery rate of over 70%, through a 10% or lower increase.

- 4. The proposed adjustments in respect of services related to the control of animals and plants and the registration of veterinary surgeons provided by the Agriculture, Fisheries and Conservation Department are set out in the Appendix.
- 5. The proposed adjustments involve a total of 69 fee items. Of these 69 items, 46 items involve an increase of 3% to 7% only and two items involve an increase of 15% following the lines set out in paragraph 3 above.
- 6. Exceptional cases departing from the full-cost recovery policy involve fees and charges related to the quarantine maintenance for plants, the disinfection treatment for plants and soil, the impounding of animals and the detention of dogs. These involve 21 subsidized fee items. The last revision was carried out in 1997/98. An increase of 2.9% is proposed to maintain the real value of these fees, based on the movement of the Government Consumption Expenditure Deflator from 1997/98 to 2000/01.

Financial Implications

7. If all the proposed fee adjustments are implemented, we estimate that an additional revenue of about \$320,000 per annum would be generated.

Further Improvement in Cost-effectiveness

- 8. The Administration will continue to undertake necessary measures to
 - (a) contain costs by continuing to implement the Enhanced Productivity Programme and taking other efficiency improvement measures; and
 - (b) review whether it is still necessary to provide the various services that require payment of fees and charges.

We will discuss the findings of the review with Members by the end of this financial year.

Implementation Timetable

9. The Administration intends to introduce the fee adjustments to the Legislative Council early in the next legislative session.

Advice Sought

10. Members are invited to endorse the fee adjustments recommended in the Appendix.
