INTRODUCTION

This paper reports on progress in the operation of the Special Finance Scheme for Small and Medium Enterprises (the Scheme).

LATEST POSITION

- 2. As of 24 February 2000, a total of 11,142 applications referred to the Government by participating lending institutions have been approved. The cumulative sums of guarantees committed and loans facilitated amount to about HK\$5,111 million and HK\$8,102 million respectively. There are 80 default cases and the Government guarantees involved in these cases amount to about HK\$81 million. The annualized default rate is 2.72%.
- 3. The detailed statistics showing the various aspects of the performance of the Scheme up to 24 February are set out at the Annex.
