SPECIAL FINANCE SCHEME FOR SMALL AND MEDIUM ENTERPRISES

INTRODUCTION

This paper reports on progress in the operation of the Special Finance Scheme ("Scheme") for Small and Medium Enterprises (SMEs).

LATEST POSITION

- 2. Subsequent to the approval of the Finance Committee on 12 November 1999, the approved commitment under the Scheme has been doubled to \$5 billion and the guarantee ceiling for individual participating lending institutions increased correspondingly from \$200 million to \$400 million. We have also revoked the deposit option under which licensed banks could demand an amount of deposit equivalent to that of the guarantee.
- As of 2 December 1999, a total of 9,191 applications referred to the Government by participating lending institutions have been approved. The cumulative sums of guarantees committed and loans facilitated amount to about HK\$3,186 million and HK\$5,230 million respectively. There are 39 default cases and the Government guarantees involved in these cases amount to about HK\$43 million. The annualized default rate is 2.4%.
