# **Revision of Government Fees and Charges of Transport Related Services**

## **PURPOSE**

This paper seeks Members' views on the proposed revision of Government fees and charges of transport related services which do not directly affect people's livelihood or general business activities.

## **BACKGROUND**

- 2. Most Government fees and charges have been frozen since February 1998 as an exceptional measure to ease the burden on the community at a time of economic setback. Given the recovery of our economy, the Financial Secretary announced in the 2000-01 Budget Speech that the Administration would approach the LegCo to discuss the revision of various Government fees and charges that do not directly affect people's livelihood or general business activities.
- 3. At the LegCo Panel on Financial Affairs on 13 April 2000, Members were consulted on proposals to revise various fees and charges that would only affect a small number of people and some specialist business. In view of the diverse nature of the identified fees and charges, some Members of the Panel suggested that the proposed revision should also be considered by the relevant subject Panel of LegCo. At the House Committee Meeting held on 14 April, Members agreed that the Administration should consult the other LegCo Panels on whether and if so how fees and charges under their respective purviews should be increased.

## FEE PROPOSAL

4. In line with the "User Pays" principle, it is important for various users of Government services to pay the costs incurred in the provision of services. The full implementation of this policy has been held in abeyance for more than two years as a result of the fee revision moratorium, which is an exceptional relief measure taken at a time of economic setback. In recognition of the current state of economic recovery and taking into account affordability and acceptability, we propose to:

- (a) make at most a 5% increase for a full-cost recovery within one year for those fees with existing cost recovery rate of over 90% (Items 1 & 3.3 of the **Annex**);
- (b) make at most a 15% increase for a full-cost recovery within five years for those fees with existing cost recovery rate of between 40% and 70% (Items 2.1, 2.2 & 3.2 of the **Annex**); and
- (c) make at most a 20% increase for a full-cost recovery within five to seven years for those fees with existing cost recovery rate of less than 40% (Remaining items of the **Annex**).

Details of the proposed fee revisions that fall under the purview of this Panel is at **Annex**.

## FINANCIAL IMPLICATIONS

5. The proposed fee adjustments if implemented will generate additional revenue of \$403,800 per annum.

## THE WAY FORWARD

- 6. We are committed to:
  - (a) contain costs by continuing to implement the Enhanced Productivity Programme and taking other efficiency improvement measures; and
  - (b) review whether it is still necessary to provide the various services under our purview that require payment of fees and charges. We will discuss the findings of the review with Members by the end of 2000/01 financial year.

## **MEMBERS' ADVICE**

7. We should be grateful for Members' views on the proposed revision of fees and charges as set out at the **Annex**.
