Chinese Medicine Ordinance, Cap. 549

CHINESE MEDICINE (FEES) REGULATION

Introduction

At the meeting of the Executive Council on 14 March 2000, the Council ADVISED and the Chief Executive ORDERED that the Chinese Medicine (Fees) Regulation, at the Annex, should be made under Section 161(1) of the Chinese Medicine Ordinance.

BACKGROUND AND ARGUMENT

General Background

2. The Chinese Medicine Ordinance (the Ordinance), enacted by the Legislative Council in July 1999, provides a statutory framework for the regulation of the practice, use, trading and manufacture of Chinese medicines in Hong Kong. The Ordinance provides for the establishment of a Chinese Medicine Council of Hong Kong to be responsible for devising and implementing these regulatory measures.

- 3. The Chinese Medicine Council of Hong Kong was established in September 1999, and proceeded immediately to prepare for the setting up of a registration system for Chinese medicine practitioners. Apart from recognizing the professional status of Chinese medicine practitioners, the registration system will help enhance the standard and public confidence in Chinese medicine practice. Statutory control over Chinese medicines will be introduced in phases commencing later this year.
- 4. The registration system for Chinese medicine practitioners will operate through a system of examination, registration and discipline. The following regulations will have to be made to provide for the registration of Chinese medicine practitioners:-
 - (a) Chinese Medicine (Fees) Regulation, to be made by the Chief Executive in Council, setting out the level of fees payable for registration as Chinese medicine practitioners and other related purposes;
 - (b) Chinese Medicine Practitioners (Registration) Regulation, to be made by the Chinese Medicine Council of Hong Kong with the approval of the Secretary for Health and Welfare, setting out the registration procedures and related matters; and
 - (c) Chinese Medicine Practitioners (Discipline) Regulation, to be made by the Chinese Medicine Council of Hong Kong with the approval of the Secretary for Health and Welfare, setting out

the disciplinary procedures to be followed in handling complaints against registered Chinese medicine practitioners.

The two regulations mentioned in (b) & (c), to be made by the Chinese Medicine Council of Hong Kong, will be tabled at the Legislative Council shortly.

The Proposal

5. In line with Government policy on fee charging, we propose to introduce fees, through the making of the Chinese Medicine (Fees) Regulation, to recover the cost of administering the registration of Chinese medicine practitioners.

THE REGULATION

- 6. The Regulation sets out the fees payable under the Chinese Medicine Ordinance in relation to registration as Chinese medicine practitioners. Clause 1 provides that this Regulation shall come into operation on a day to be appointed by the Secretary for Health and Welfare by notice in the Gazette.
- 7. Clause 2 provides that the fees set out in the Schedule are payable under the Ordinance.
- 8. Clause 3 provides that all fees set out in the Schedule that have been received shall be paid into the general revenue.

BASIC LAW IMPLICATIONS

9. The Department of Justice advised that the Regulation is consistent with the Basic Law.

HUMAN RIGHTS IMPLICATIONS

10. The Department of Justice advised that the Regulation has no human rights implications.

BINDING EFFECT OF THE LEGISLATION

11. The Regulation will not affect the current binding effect of the Ordinance.

FINANCIAL AND STAFFING IMPLICATIONS

- 12. The Department of Health will require a secretariat of 12 staff at a full annual cost of about \$9 million to serve the Chinese Medicine Council of Hong Kong and to administer the registration system.
- 13. The proposed fees will give rise to annual revenue of about \$6 million.

14. The Chinese Medicine Council of Hong Kong has been

consulted and has raised no objections. Consultation with the general public

is not considered necessary, as they are not likely to be affected by the

proposed Regulation.
