Security And Guarding Services (Fees)

(Amendment) Regulation 2000

(Made by the Chief Executive in Council under section 30(1),

(1A) and (1B) of the Security and Guarding

Services Ordinance (Cap. 460))

## 1. Commencement

This Regulation shall come into operation on a day to be appointed by the Secretary for Security by notice in the Gazette.

## 2. Section substituted

Section 2 of the Security and Guarding Services (Fees) Regulation (Cap. 460 sub. leg.) is repealed and the following substituted---

- "2. Fees prescribed for the purposes of the Ordinance For the purposes of the Ordinance---
- (a) the fees set out in Schedule 1 are prescribed in respect of permits and are payable to the Commissioner; and
- (b) the fees set out in Schedule 2 are prescribed in respect of licences and are payable to the Authority.".
- 3. Sections repealed

Sections 3 and 4 are repealed.

4. Section added

The following is added---

"7. Savings and Transitionals

If, immediately before the commencment of sections 3, 5 and 6 of the Security and Guarding Services (Fees) (Amendment) Regulation 2000 (L. N. 134 of 2000), a licence fee was payable under this Regulation as it then applied (whether allowed to be paid by instalments under the repealed section 4 or otherwise), then the licence fee remains payable, and this Regulation as it then applied continues to apply in respect of the licence fee, as if those amendments had not been enacted.".

5. Schedule substituted

The Schedule is repealed and the following substituted---

Explanatory Note

This Regulation amends the Security and Guarding Services (Fees) Regulation (Cap. 460 sub. leg.) ("principal Regulation"). Firstly, it repeals provisions that relate to payment of licence fees by instalment in the principal Regulation. This reflects the change made by the Security and Guarding Services (Amendment) Ordinance 2000 (25

of 2000) in replacing the existing licence fee (being one fee payable by annual instalments) by an annual fee. Secondly, it prescribes the fees payable---

- (a) for an application for the issue of a permit and for its issue;
- (b) for an application for the renewal of a permit and for its renewal;
- (c) for an application for the issue of a licence;
- (d) for an application for the renewal of a licence;
- (e) annual fee of a licence issued or renewed;
- (f) for the replacement of a permit or a licence.
